

## Hourly rate and approved duration of treatment

The maximum 5-minute rate is determined by the therapist's training and the registered method of complementary medicine for the tariff structure 590. It applies only to the following complementary medical services (incl. VAT) and is based on the average costs for the comparable service provider group. More methods are constantly added to this list.

Therapists can charge a higher amount if they wish. However, the amount paid by CSS Versicherung AG is limited to the maximum prices as listed. Therapists have to inform their clients about the out-of-pocket costs to be settled by them (duty to provide information).

All services are invoiced in 5-minute units.

The price for tariff code 1200 (taking of medical history, examination, diagnosis, recording the findings) may not exceed the 5-minute rate.
